- These Standalone and Consolidated Financial Results were placed before and reviewed by the Audit Committee at its meeting held on 07th September, 2019 and approved by the Board of Directors in its meeting held on the same date. The above results have been subjected to Limited Review by the Statutory Auditors.
- 2. The Company has adopted Indian Accounting Standards ('Ind AS') notified under Section 133 of the Companies Act, 2013 ("the Act") read with the Companies (India Accounting Standards) Rules, 2015, from 1st April, 2019 and the effective date of such transition is 1st April, 2018. Such transition has been carried out from the erstwhile Accounting Standards notified under the Act read with relevant Rules issued thereunder (referred to as "the Previous GAAP"). The impact of transition has been recorded in the opening reserves as on 1st April, 2018 and the corresponding figures presented in these results have been restated/reclassified. The above financial results have been prepared in accordance with recognition and measurement principles laid down in Ind AS 34- Interim Financial Reporting prescribed under Section 133 of the Act read with relevant Rules issued thereunder.
- 3. In terms of the circular no. CIR/CFD/FAC/62/2016 dated July 05, 2016 issued by the Securities and Exchange Board of India the Ind As compliant Unaudited Financial Results for the quarter ended June 30, 2018 have not been subjected to Limited Review by the Statutory Auditors. However, the management has excercised necessary due diligence to ensure that the Financial Results for the said period provide a true and fair view of its affairs.
- 4. As required by Paragraph 32 of Ind AS 101, the profit reconciliation between the standalone figures reported under the Previous GAAP and restated as per Ind AS is as under:

- 5. The Company has adopted Ind AS 116, which became effective for reporting period beginning 1st April 2019 and applied the standard to its lease arrangements using the Modified Retrospective Approach. The cumulative effect of application of the standard has been recognised on the date of initial application (1st April 2019). This has resulted in recognition of a right-of- use asset of Rs. 24.9 Lakhs and a corresponding lease liability of Rs. 24.9 Lakhs (net of payments made) as at 1st April 2019. Consequently, the lease rent expense, in respect of operating lease, is now partially reflected under Depreciation, on right-of- use asset, and partially under Finance costs as interest on operating lease liability.
- 6. The Comapany is registered as NBFC with RBI & at present there are no reportable segments as per Indian Accounting Standard 108 on "Operating Segments" in respect of the Company.
- The company has brought forward losses under the Income Tax Act.In the absence of reasonable certainty regarding the realisation and for reasons of prudence, credit for Deferred Tax Assets has not been recognised to comply with Accounting Standard AS 22
- The consolidated financial results include consolidated results of the following companies:

- 9 The Consolidated financial figures for the comparative quarter ended June 30, 2018 as reported in these Consolidated Financial Results have not been subjected to limited review.
